**Management System:** Alaska salmon is primarily managed by the Alaska Department of Fish and Game and the Alaska's Board of Fisheries. In addition, Alaska's Sustainable Salmon Fisheries Policy and the Pacific Salmon Treaty (PST) also provides guidance to the salmon management regimes that provide updated information on stock status, harvest guidelines. About 167 million salmon have been commercially harvested since 2000. Alaska fishermen can only participate in the commercial salmon fisheries by holding limited entry permit or by working as a crew member for a limited entry permit holder.

**Chain of Custody:** For the Alaska salmon fisheries, all landings are recorded and reported through fish tickets. Processing occurs predominately at shore-side plants where landings are monitored by fishery enforcement officers and recorded by each licensed processing facility. Each processor controls the transport of its product from landing locations to processing facilities. Sufficient monitoring takes place to identify the fishery of origin for all landed Alaska salmon, allowing a Chain of Custody to be established from the point of landing forward for all products derived from the fishery.
